Mr. Mandel asked for a motion to approve the banks. Mr. Yost made the motion and Ms. Murnieks seconded. Motion carried.

Also under new business Mr. Mandel asked for a motion for the Board to ratify \$3,847,700,083.60 as interim funds for July 2012. Mr. Yost moved and Ms. Murnieks seconded. Motion carried.

CERTIFICATION OF BOARD EXPENSES

In accordance with Section 135.02 of the Ohio Revised Code, the Chairman and the Secretary of the State Board of Deposit certified that the necessary expenses of the Board which represent KeyBank banking fees for July 2012 were \$109,399.24. KeyBank Trust banking fees for July 2012 were \$6,690.01. KeyBank warrant settlement fees for July 2012 were \$6,639.21. Charter One banking fees for ODNR Portsmouth were \$121.53 for July 2012. PNC banking fees for ODNR Mine Subsidence were \$903.23 for July 2012. OAKS voucher processing fees / postage were \$2.12. Mr. Yost made a motion to authorize the Chairman to pay these expenses from the appropriations for that purpose. Ms. Murnieks seconded. Motion carried.

There being no further business to come before the Board, Mr. Mandel adjourned the meeting.
