Course Name	Course Description
<b>Governing Laws, Regulations and Policies</b> Katie Johnson, Deputy Executive Director, Ohio Association of School Business Officials (OASBO), Ryan Pendleton, Treasurer/CFO, Akron City SD	<p>This course covers a number of both federal and state laws as well as other sources of authority which govern school operations, including Ohio Revised Code, Sunshine Laws, Public Records as well as board policy guidelines.</p>
<b>Ethics</b> Katie Johnson, Deputy Executive Director, Ohio Association of School Business Officials (OASBO)	<p>This course will cover the rules and requirements of Ohio Ethics Laws and related statutes applicable to public officials, including school district treasurers. Topics covered will include the limits and ramifications of public officials and employees from engaging in the following:</p> <ul style="list-style-type: none"> <li>• Participating in their public role in any action that involves the direct interests of the official, or those of a family member, or another with whom the official has an ongoing private business relationship;</li> <li>• Authorizing , or using his or her public position to secure, a public contract or the investment of public funds in any security that benefits the official, a family member, or a business associate;</li> <li>• Improperly profiting from a public contract;</li> <li>• Soliciting or accepting substantial and improper things of value, including, outside employment or consultation fees, gifts, or travel, meals and lodging, from those dealing or seeking to do business with the public agency; and</li> <li>• Unauthorized disclosure or use of information deemed confidential by law.</li> </ul> <p>In addition to the topics listed above, the financial disclosure statement that all school district treasurers must file will be discussed.</p> <ol style="list-style-type: none"> <li>1. Understand the Ethics Laws and related statutes as they apply to activities affecting school district CFOs and other district employees.</li> <li>2. Be able to spot potential conflicts of interest and other ethical issues before they become problems, and address them.</li> <li>3. Be able to communicate these issues to school boards and the public on topics of Ohio Ethics Laws.</li> </ol> <p>1 The course will enhance the attendees' understanding of the Ohio Ethics Laws and related statutes so that school district officials and employees can understand the rationale behind the laws in order to assist in identifying issues and helping to protect themselves and their districts from violations and liability, as well as to protect the public's trust in our public agencies.</p>
<b>Student Activity Programs</b> Jennifer Vanover, Executive Director, Data and Processes, Columbus City Schools	<p>In view of the large amounts of monies received from and expended for student activities, a demand was developed for efficient, thorough, and safe management of these funds. Every board of education should have in effect rules, regulations, and procedures for accountability of student activity funds.</p> <p>This session covers all aspects of fund raising including legal authority and establishment, administrative responsibilities, district managed policies, budgetary process, crowdfunding, education, internal controls on purchasing and cash, the do's and don'ts of fundraising, and the audit.</p>
<b>Booster/Support Organizations</b> Matt Stout, Partner, Public Finance, Bricker Graydon LLP, Rebecca Jenkins, Treasurer, New Albany Plain Local SD	<p>This course will provide participants a background on school booster and support organizations and how to manage them effectively to the benefit of both the organization and the school district.</p> <p>2 Understanding how to manage school booster and support organizations protects both the organization and the school district from potential liability. It also allows school districts to maximize the support from such groups to benefit the individual school district. It is essential that school business officials understand how to effectively manage these organizations while protecting their school district.</p>

Understanding all aspects of the purchasing procedure is a key component in school finance. Implementing internal controls, written procedures and following best practice is very beneficial in protecting district funds</div></div>

This information is critical when deciding how best to invest the funds of the district. Information will be included on the types of investments available along with ideas on establishing an investment outlook and strategy. Details will be provided on best practices for monitoring investments, rebalancing when needed, investment accounting and reporting results.</div><div>The course will provide a review of various types of investments available to public school districts.
